How To Prepare And Mail Your Board Election Ballot

- 1. Put a mark in the "Mark to Vote" column for each candidate, up to the maximum number allowed per the instruction on the ballot. Please return your ballot even if you choose not to vote for any candidate, so that you will count toward a quorum. If you vote for more than the maximum allowed, your ballot will be marked "Spoiled" and no votes will be counted. If you put a mark for a candidate you don't want to vote for, clearly cross out both the name and the mark for that candidate.
- 2. Fold the ballot so that it will fit into a Signature Envelope. Place folded ballot into the Signature Envelope and seal the envelope. Print your name and sign your name on the front of the Signature Envelope. There must be a signature and legible printed name for the vote to be valid. If you are family members and returning two ballots, both can be placed in the Signature Envelope with both names printed and signatures applied.
- 3. Place the prepared Signature Envelope into a Return Envelope. If you are making your dues current or are a new member paying your dues with your ballot return, place your payment and a filled in Membership Form with the Signature Envelope in the Return Envelope. The Return Envelope must be in the WVS P.O. Box on or before October 7th 2022. Address the Return Envelope to WVS P.O. Box 446 Westport, CA 95488.
