The WVS would like to share some announcements and seek declarations of interest from members interested in running as candidates for two Board positions.

As mentioned in last

month's newsletter, WVS quarterly Board Meetings are now held on the 4th Wednesdays in July, October, January, and April at 6:30 pm. They will continue to occur by zoom to facilitate participation. The goal is to make WVS Board Meetings as accessible as possible.

Among other matters discussed at the July 28 board zoom meeting, WVS approved procedures for member voting using mailed ballots. We held our first mail election last year due to Covid and discovered a sizable increase in participation. So we plan to make the change permanent. The newly approved voting procedures are carefully designed to ensure the integrity of elections with results announced at the Annual Member Meeting.

Two WVS Board positions will be up for election this year. Directors serve 3-year terms to further the goals of our nonprofit. Visit

Your name will also appear on ballots the WVS sends to members and prospective members in mid-September. Your statement should explain why you are interested in running and something about your background/skills.

A ballot and membership applications will be mailed several weeks prior to that meeting. Community Garden I try to minimize our water usage by implementing a couple of water conservation techniques which you could also utilize around your own home and garden:

• Top-dress your garden beds with rice hulls, mulch, straw, hay or even cardboard to prevent topsoil evaporation.

• Try not to water in the heat of the day. It's best to water early morning or evenings to prevent evaporation loss and the burning of your plants.

• Don't play the game of "catch up". Water your garden consistently - if your soil dries out too much it may become hydrophobic and will then require ample amounts of water to get back to base saturation levels.

• Plant flowers and other

ornamentals that are native to California and/or are drought tolerant.

• Choose containers to grow in that hold moisture well and don't dry out quickly.

• Adding a bit of moss and/or coco coir to your soil can help retain moisture and cut down on watering.

• Drip irrigation is a great way to cut down on usage by delivering precise amounts of water directly to the plants' roots.

The **Community Garden** work days are the first and third Saturdays of the month @10:30AM (weather permitting). But please also feel free to stop in anytime you feel like getting your hands in the dirt - there are always weeds that need to be pulled, vines that need to be trellised and veggies harvested this time of year. If you are uncertain about what to do, just check the white board inside the greenhouse for up-to-date tasks/jobs needing to be done around the garden. Thank you to everyone who has contributed to the Garden in some way and has helped to make it into what it is today. It's really starting to come together for us and I'm excited for the future! **Happy Summer Everyone!!**

To our valued customers:

The estimated July total water used by our District is 578,736 gallons. This is a 3% reduction from the 2020 July total. This is in the right direction toward the voluntary reduction goal of 20% requested by Mendocino County

When you get your June bill, please review it and consider what you can do to reduce your water consumption, especially if you went over your baseline.

The Westport County Water District Board of Directors and I have been working diligently on our Drought Emergency Plan. I am hoping to have a finalized and adopted plan very soon. This plan will spell out when we, as a District, need to get very serious about conserving water. Every customer will know what will be needed from them in the way of water use and conservation and why this is necessary.

On another note, we recently had to pull a sewer lift pump out of the sewer lift station and send it off for repair. The pump was jammed with an undergarment. This has happened several times before and this time the pump did not survive. Please help us keep our cost down by not flushing any trash, feminine hygiene, baby wipes or incontinence products down the toilet.

Blues Beach Land Transfer

We thank many locals who share our belief that we have a historic opportunity to support descendant tribes who seek to protect and manage Blues Beach as it was originally intended.

Caltrans acquired the 172 acres associated with the Blues Beach property in the mid-1970s with Scenic Easement funding. That grant money mandated protection of the property's diverse environmental resources. Sadly, that promise was not kept. Camping, fireworks, and driving on Blues Beach have been illegal for many decades, yet they are pursued with impunity. The County Sheriff and State Parks claim to lack jurisdiction. The California Highway Patrol is technically responsible, but rarely visits or takes action; nor do they typically prioritize enforcement of local ordinances. Cal Fire also has peace officers, but they are stretched thin dealing with illegal fireworks across the entire state. As a result, the beach access at Chadbourne Gulch is monopolized by people who hold resource protection, the law, and broader public interests in contempt.

The situation has escalated to epidemic proportions in recent years, attracting outlaws from far flung areas. Many locals stopped visiting Blues Beach long ago as it has grown increasingly unsanitary, hostile, and unsafe to visit.

After many years of careful consideration and negotiation, Senate Bill 231, proposed by State Senator Mike McGuire and Assemblyman Jim Woods has been structured to ensure that the property transferred to a tribal nonprofit will protect cultural and natural resources while maintaining lawful public access. We encourage you to read the bill and contact your state representatives with any questions.

The proposed nonprofit consortium of descendant tribes (Sherwood Valley Band of Pomo Indians, Coyote Valley Band of Pomo Indians and Round Valley Indian Tribes) have a vested interest in protecting ancestral village sites, shell middens, ceremonial areas, and wild-harvesting grounds on the property. They have ties to this property going back thousands of years.

The transfer will ensure that conservation and lawful coastal access will be maintained under the law, while development will be precluded. It is also a small step toward acknowledging and redressing losses faced by the indigenous inhabitants when their lands were violently usurped during American colonization. Nothing can undo or make amends for those atrocities, but this transfer is a form of reparation.

This is why a substantial majority of Westport residents, along with hundreds of supporters throughout Mendocino County have signed a local petition at the Community Store and a Change.org petition supporting Senate Bill 231. It is a gesture of goodwill. Thank you for standing with the tribes in solidarity.
